Message from the CEO Welcome to all our valued customers.



As we enter the second half of 2020 we are all hoping that Zimbabwe has been spared some of the terrible consequences of the Corona Virus that other nations in the world have faced. Many of the restrictions have been lifted and business, as we know it in Zimbabwe, is getting back to normal. Transport limitations have not been totally removed and most workers, especially those starting early shifts, are facing difficulties in reporting on time.

The newly implemented auction system has seen the official inter-bank exchange rate rise 150% in 8 days from ZWL25 to ZWL63 to one US dollar and even this is some way off the unofficial parallel rate. This huge devaluation in the inter-bank rate has led to yet further increases in all basic products, including commuter fees and basic food stuffs, leaving our employees struggling to sustain themselves on the wages we are able to pay

We have taken the decision, in line with Government directives, to indicate charges in both US\$ and ZWL. The cost of a monthly 12 hour guard has been set at US\$400 (translated at the auction rate at the beginning of the month) which is well below the US\$715 charged before the local currency was reintroduced. Whilst this is a huge increase in local currency, we are worried that it may still not be enough to pay the guard a living monthly wage. The fact that his end of month pay is based on an exchange rate we are charging you at the beginning of the month, any large variation during the month will significantly reduce his earnings and we may be forced to review the position in the future. We will keep you informed of developments.

We have recently reintroduced our investigations department and taken it out of normal operations. We have appointed Mr Antony Mangezi who has extensive police experience to head this division up and we are sure that putting it under a dedicated manager will result in more efficient investigations and running of undercover operatives. Welcome to the team Antony.

In this issue you will find articles on both Home Security audits and Keeping your work place secure. These are both very pertinent, in the current economic and crime scenario we find ourselves in, I urge you to take cognisance of the contents.

The Video Intercom





As a home or business owner, you need to be always vigilant. And for security reasons, you need to know who is at your door or gate before you grant them access. Unwanted surprises can be a risky affair. No unauthorized person ought to walk into your private home or office without your permission. It needs to be secured accordingly. Guard-Alert Electronics offers a solution that allows property owners to have discrete entry access control; the video intercom. This provides much needed security by enabling you to see the visual non-verbal cues of those wanting to gain entry into your premise which can announce someone with hostile or malicious intent. The video intercom is a stand-alone intercom system that manages the calls made at the entrance of your home or business. Visitors can make a call by pressing a button on an externally mounted terminal equipped with a camera and a speaker. When a visitor presses the call button on the video intercom, the camera is activated and the image of the person at the gate appears on the indoor monitor. As a host, you are able to view your caller and communicate with him/her through a receiver monitor.

The monitor has a door Unlock button which, when pressed, releases the gate/door for your visitor to gain access. You can opt to deny visitors access. If you suspect that your door caller is not a genuine person, you can quickly take the necessary security precautions after denying them access. This gives you a layer of protection not normally afforded.

A more sophisticated video intercom has an inbuilt memory that records the images of visitors with time stamps and dates which can be reviewed at a later date. This assurance of visual confirmation in knowing who is coming and going from the property lends confidence to the overall system in case of any unlawful entries.

In addition to this, infrared technology can capture images in the sunshine, overcast or night providing clear and unambiguous evidence if and when peeded

CRIME TRENDS

NATIONWIDE

The COVID-19 pandemic has left a lot of people without income. This, coupled with the current economic resulting which is characterized by a significant increase prices environment due to the liberalization of the monetary system is not making it any better. As a result, there has been an upsurge in both violent and petty crimes throughout the country.

There have been several reports where people have been attacked by criminals especially at month end. The criminals are targeting essential workers who haven't been affected by the national lockdown due to the COVID-19 pandemic. Targeted items are food stuffs, cell phones and cash, both local and foreign currency. In the case of cell phones, the victims are forced to give up their mobile money PIN codes before the criminals make off with the cell phone.

Drivers Beware! Motorists are warned not to give lifts to strangers as criminals now pretend to be genuine commuters. The criminals usually travel in groups of two to four people who pretend to be travelling independently. After travelling for a while, the criminals then produce weapons and threaten the driver and other passengers in the car robbing them of their valuables and in most cases dumping them in a remote area as the thieves use the car as their getaway vehicle. Some criminals have also devised a trick in which they cause a "minor accident" with a targeted car before robbing the owner.

On the flip side, commuters should also exercise extreme caution when boarding private vehicles. Innovative robber, pretending to be 'Good Samaritans', have devised new methods of stealing by targeting unsuspecting commuters. We, at Guard-Alert urge commuters to be discerning before using public and private transport vehicles.

On the 9th of May 2020 three (3) machete-wielding robbers raided a residential property in Penhalonga and robbed a couple of cash and household property worth USD6 000, before taking turns to rape the woman. The trio severely assaulted the man with a machete all over his body, before tying him with a rope. After

raping the helpless man's wife (names withheld to protect the identity of the rape victim), the gang vanished into the darkness. The three are still at large and the police are appealing to members of the public with information on the three suspects to contact their nearest police station. Manicaland provincial police spokesperson, Inspector Tavhiringwa Kakohwa confirmed the incident.

On 10 May 2020, thieves broke into a commercial property. They forced entry through the front door by breaking the padlocks using a bolt cutter. Items stolen from the shop included several bottles of cooking oil, several packets of rice, a BP testing machine, airtime and a cell phone. The client had left the alarm not armed citing that there was no electricity. A report was made to the police the following morning and the accused are still at large.

On 2 June 2020 at 1630 hours one of our security guards arrested employee of this shop for theft of company property. On 5 June 2020 at 1104 hours guards arrested a Merchandiser at the same shop for theft of company property. Both matters were dealt with internally.

On 9 June 2020 at 1530 hours one of our guards arrested an employee for theft of liquid soap which was concealed under the accused's shirt. Matter was referred to management who dealt with the accused internally.

On 10 June 2020 at 0105 hours our armed guard who was on duty observed two intruders walking towards the main

building and ordered them to stop. The intruders however, failed to heed forcing the armed guard to fire a warning shot in the air causing the intruders to flee. Nothing was stolen.

On 11 June 2020 at 1730 hours our guard arrested an employee for food stuffs from the company. The accused was taken to Police.

While monitoring the CCTV on 12 June 2020 at about 0400, our guards detected a criminal entering the Store room through the ceiling. Police were then in and a search was conducted. The criminal was found hiding in the ceiling. The guards had to use a pepper spray to force the criminal out of the ceiling. The accused was taken to

On 18 June 2020 at 1225 hours our guards arrested a cleaner for theft of company property which he wanted to smuggle out of the shop concealed in the rubbish. The accused was handed over to Police.

On 19 June 2020 at 1855 hours our guards together with the Warehouse Manager arrested a security guard from another security company for theft of 28 x50kg empty grain bags from the warehouse where accused was quarding. Accused was handed over to Police.
